What is Child Find?

Child Find is a part of a federal law called the Individuals with Disabilities Education Act (IDEA) that mandates schools to locate and identify children and youth ages 3-21 with suspected disabilities who may be entitled to special education services.

Who is covered by Child Find?

Children with disabilities from birth through age 21 are covered. This includes children who are being homeschooled or who are in private school as well as highly mobile/migrant/ and/or homeless children. Child Find also covers children suspected of having a disability who are advancing from grade to grade.

What help is available?

A complete evaluation and, if appropriate: An Individualized Education Program (IEP) for children with a disability beginning at age 3, An Individual Family Service Plan (IFSP) for each child with a disability birth through 2, or A referral to other agencies when needed

### What is NC MTSS?

Family engagement within an MTSS is defined as the active and meaningful partnerships that educators build and maintain with students' families for the purpose of supporting student learning. It embodies the idea that all parties are equally invested in the student's educational experience and all parties bring knowledge and skills of equal value to the table to work together. *This linked infographic is intended to support NC families in understanding what NC educators are referring to when they are talking about an MTSS.*
